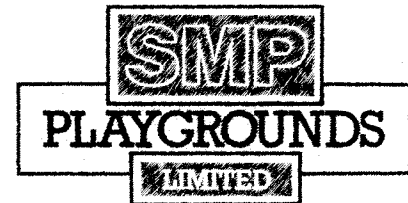

CARRIAGE: Orders valued over £3000: FREE OF CHARGE. Orders valued up to £500: 7.5%. Orders valued between £500 up to £1000: 5%. Orders valued between £1000 up to £3000: 2.5%.

DELIVERY: Approximately 6/8 weeks from receipt of order.

NOTE: Playscreed is manufactured in Red, Green and Black, the price being the same for all colours (this does not apply to Action Mat tiles). If no colour is specified on an order then black will be supplied.

Please note that delays in the laying of Playscreed tiles can occur as a result of wet or frosty weather.

\*SEASONAL SURCHARGE: Should it be necessary to lay Playscreed tiles during period of 1st October to 31st March, in any year, then a surcharge of 30% will be applied to the cost of laying the tiles only. Naturally this surcharge does not apply to the equipment or its installation neither does the surcharge apply to the actual tiles, or the concrete base only the installation of the tiles. This surcharge is detailed for your information before the final total of the quote.

When Playscreed or Action Mat tiles are laid to an existing base or a base prepared by others, we cannot then guarantee the evenness of the finished surface, in such situations puddling (in rain) and unevenness may occasionally occur. For this reason we recommend that new bases are laid on all surfacing installations.

PLEASE NOTE: On orders received with installation a minimum installation charge of £200.00 applies in all cases.

For the purpose of this estimate we have assumed that easy lorry access and precise siting of the equipment will be provided, no reduce level digging or filling to make up levels is required, no surface or underground obstructions will be encountered during excavation such as concrete, hard-core, rock, chalk, roots, drainage, gas or water pipes, telephone or electricity cables etc. In the event of any such obstructions we reserve the right to charge for any additional work involved. We cannot accept liability for any consequent charges that may be incurred by disruption of any of the foregoing services. All surplus excavated material to be deposited on site.

Where installation is required onto new concrete bases the following leave time must be accepted in order to allow the concrete to gain its full strength:

- a) Action Mats 3 to 4 weeks
- b) 2-2-7 3 to 4 weeks
- c) Playscreed tiles 1 to 2 weeks

2. ACCEPTANCE
