Precept

It was decided that a precept for 1997/8 should be made for £13,500, composed of £9,500 for the year's running expenses, £500 for car park repairs, £500 for the sub-way mural, £1,000 to provide water supply and tap in the Burial Ground and a grant of £2,000 towards the cost of rebuilding the Committee room wall at the Village Hall. It was also decided to grant the Management Committee a loan of £1,000 repayable within the year.

Mr Bartleet said that the County Council was proposing to deal with the humps in the road surface on the fly-over bridge and to carry out repairs to Salford Road. Mrs Tiwari would ask Mr Tiwari to support these repairs.

The Clerk was asked to request the County Council to replace the existing chevron sign with a slatted version.
