#### Recreation Ground

The Clerk had received insurance details requested from Northway Boys F.C.

A quotation for car park repairs, replacing manholes etc. in the sum of £4622.78 was received. This was not accepted.

#### Highways

It was noted that the City Council were intending to bid for £30,000 from the County Council for traffic calming at unspecified sites and roads in Old Marston. This would also be subject to Department of Transport approval.

The Clerk was asked to write to the City Council to ask for signs indicating the vehicular route to the Schools, for the existing sign to be amended to indicate that the route was for pedestrians and for the sign at the entrance to Oxford Road (North) to be altered from "Marston Village" to "Old Marston".

#### Burial Ground

The Clerk had received confirmation from the purchaser of Plot B9 that it could be transferred to the favour of Mrs M Hunt. She did not currently qualify for interment under the existing rules but it was decided that an exception could be made in this case.

#### Other Matters

Mr C Haynes conveyed the Village Hall Management Committee's sincere thanks for the Parish Council's support towards the cost of the recently completed work.
