A request that a hand rail should be provided to the bridge on the allotment footpath was not proceeded with.

The Chairman reported that due to absence abroad he had been unable to call a meeting of the Mural Sub-committee.

The Chairman had investigated the tarmac repairs where kerb stones have been removed and he had been assured that this was a temporary measure on safety grounds.

It was reported that green refuse bags for garden rubbish could be purchased from the Northway Centre Mon-Fri, 9-12.30 and 1.30-5 except Thursdays 9-11.
