the County Planners who expressed some amazement at the statement. They would investigate.

The Environmental Health Officer had referred the storage of paint at 48, Oxford Road to the Fire Service who had given appropriate advice.

The Clerk reported that the Parish Council's preferred option for the Park & Ride to serve the Oxford Radcliffe Hospital adjoining the A40 was not being supported by other agencies. After some discussion it was decided that the Council should press for the use of the Pear Tree and Thornhill sites. This would have the added advantage of discouraging traffic from using the Marsh Lane fly-over.

#### Mill Lane Site

The Planning Consultant was expecting to submit the Outline Planning Application within the next two or three weeks. Further minutes and correspondence, containing further inaccuracies were received from the Old Marston Residents' Association. It was decided to take no further action.

#### Venue for meetings

It was decided to accept the Village Hall Management Committee's invitation to hold the June meeting at the Mortimer Hall.
