## **ENV 21/03/05 Future Idea Relevant to this Committee:**

- More tree planting, hedges, and wildflowers: The Boults Lane boundary hedge, with the allotments, is overgrown with gaps and needs serious work done. This would be too big for a group of volunteers. It was RESOLVED the Clerk confirm boundary ownership.
  Cemetery Extension and side paddock: Once the extension had been finalised a hedge and wildflowers could be laid along the new fence.
- More bulbs planting: AM advised that most of the bulb planting was in grass verges so outside the Parish Council control.
- More Bird Boxes: No specific location but additional sites could be found.
- Have a Parish Council map of the footpaths around the Parish with points of interest marked on it: Need to know where the Rights of Way are. AM used an artist who works for Greenprint for the Marston Community Garden map. It was RESOLVED to recommend to the Council that a map of the Parish highlighting footpaths and interesting point be investigated further.

• To open the Cemetery Store Garage so people can make drinks, rest, cut flowers: As there is no electric or water supply to the garage this was impractical.

## **ENV 21/03/07 Information sharing (including correspondence)**

CV stated that a Low Cardon Neighbourhood was a radical idea as it means blocking off roads. This would cause an issue for buses. Rising Bollards was discussed and whether it plausible making Oxford Road and Elsfield Road one way.
