It beggars belief that in a democratic society, Oxfordshire County Council can ignore a petition of over 500 signatures as well as objections from Old Marston Parish Council and our local City councillors to desist from 'improving' Back Lane, a unique 'Green Lane' in the parish, unusually rich in its biodiversity. Re-surfacing the path and 'culling overgrown vegetation' will inevitably affect the habitat and, despite reassurances from the Director for Environment, Mr Cotton, cause significant harm. The focus seems to be in making the lane a cycle track, by laying a hard surface, although in a letter to one of our Parish Councillors, Mr Bbosa, Senior Transport Planner, contradicts himself when he says 'we clearly do not propose to hard surface the path'. His letter goes further and states that 'there is no proposal to widen the path' which makes it clear he hasn't visited the site since in converting it into a route suitable for cyclists would mean cutting hedges and destroying bushes would be inevitable. Improvements, he says, are intended to be 'sympathetic to the sensitivities of the area'... but not it seems to local residents. Alternative routes for cyclists are either said to be unaffordable or have yet to be forthcoming, despite the fact that at a recent meeting of Councillors, to which the County were invited but couldn't come, it was suggested that monies might be made available to the Parish to create improvements that would make such alternative proposals possible.

It feels increasingly to us at the Parish Council, and to the residents we represent, that our opinions count for little and decisions are made that in no way accord with local sentiment. Pedestrians, dog walkers and the occasional horse continue to enjoy this piece of rural tranquility. Even the occasional wet patch doesn't deter people who value this piece of medieval green belt, a piece of land which hitherto the County has taken no interest in.

Old Marston has already been deprived of a significant amount of Green Belt for housing. We are determined to lose no more.
