

T H I S D E E D is made the *Twenty-fifth* day of *February*
One thousand nine hundred and eighty-two B E T W E E N THE PARISH
COUNCIL OF MARSTON in the County of Oxford (hereinafter called "the
Council") of the one part and ROSEMARIE DELVES of 14 Boults Lane
Old Marston in the County of Oxford (hereinafter called "the Grantee")
of the other part

W H E R E A S :-

- (1) The Council is seised in fee simple of certain land situate to the north east of Boults Lane at Old Marston aforesaid
- (2) The Grantee is seised in fee simple of the land and premises known as 14 Boults Lane aforesaid as the same is more particularly delineated on the plan annexed hereto and thereon edged in red
- (3) The Grantee has with the consent of the Council connected her said premises to the main sewer constructed beneath the land of the Council and the Council has agreed for the consideration hereinafter mentioned to grant the rights herein set forth

N O W THIS DEED W I T N E S S E T H :as follows:-

1. IN consideration of the sum of TWENTY FIVE POUNDS now paid by the Grantee to the Council (the receipt whereof the Council hereby acknowledges) the Council as beneficial owner hereby grants unto the Grantee full right and liberty to lay and maintain a foul sewer in the approximate position indicated by a blue line on the said plan for the purpose of connecting the Grantee's said premises to the main sewer TOGETHER WITH all necessary rights at all times hereafter to enter upon the land of the Council with or without all necessary workmen and equipment for the purpose of repairing renewing and relaying the said pipe the Grantee and her successors in title making good all damage occasioned to the land of the Council in the exercise of such right TO HOLD the same unto the Grantee in fee simple
2. THE Council hereby acknowledges the right of the Grantee to production and delivery of copies of the documents of title more

particularly specified in the Schedule hereto and hereby undertakes for the safe custody of the same

3. IT IS HEREBY CERTIFIED that the transaction hereby effected does not form part of a larger transaction or of a series of transactions in respect of which the amount or value or the aggregate amount or value of the consideration exceeds Twenty thousand pounds

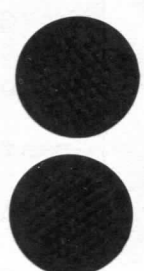

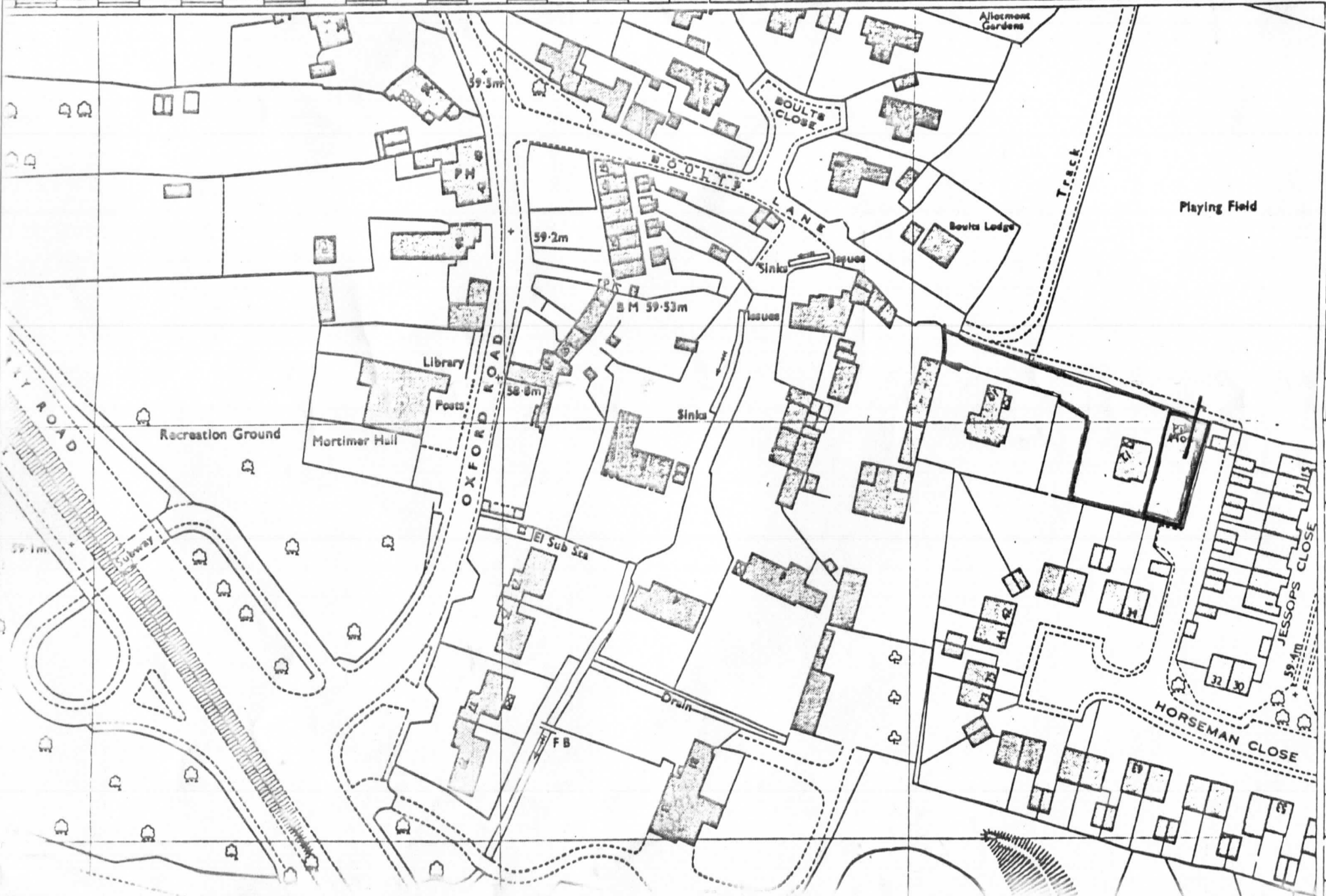
