#### **Highways**

Mr. R. Dix, Chief Engineer, Oxfordshire County Council and Mr. J. Keen, Principal Engineer, Oxford City Council who have joint responsibility for deciding priorities and allocating finance for maintenance of local roads attended the Meeting by invitation. They explained how the system worked and how constrained they were by financial controls and allocations, there being limited funds made available from Government grants and from the Council Tax. The outlook looked brighter for the next two years as additional funds had been promised.

A general discussion ensued and questions answered following that the Chairman thanked them for attending the Meeting that they left.

This includes the Old Marston area. He briefed the Council on progress so far and had requested that further consideration of a Park and Ride in this area should only follow a full enquiry. He was hopeful that he would be invited to attend further meetings.

The engineers confirmed that the set of swings on the Mortimer Hall site were beyond

Ms. Bradley's suggestion that consent to the provision of swings and goal posts on the Mill Lane site should be sought from the OPT was agreed. There was a considerable quantity of rubbish on site, which it was hoped that the City Council would remove.

The Clerk was asked to write to the City Council to enquire whether there was any possibility of acquiring the land between the Boults Lane site and Marsh Lane.

The Clerk would write to Wadworths to expedite the erection of the sign at the access to

The Victoria Arms. The Clerk would write to the City Council concerning overhanging vegetation at the corner of Salford Road and Cavendish Drive.

The Chairman said that his family trust wished to donate a seat to the Parish to be placed, subject to the consent of the City Council, in the bus shelter in Elsfield Road. This was accepted gratefully.

A reply was received concerning the request for the footpath at the end of Edgeway and Ferry Roads to be upgraded to a cycle route. It had been refused, objections having been received from nearby residents.
