A file of letters written by the Clerk, since the last meeting, was circulated to give Member's some background to the actions taken in the preceding month. It was decided to continue this practice

Miss Bradley questioned whether it would be possible for drafts of letters written to be approved by a sub-committee between meetings. It was pointed out that as the actions of a sub-committee were normally ratified at the following Council meeting the procedure would result in a delay of one month in dealing with correspondence which would be unacceptable. It would also be an overburden to circulate to all members all letters received. The Chairman undertook to review this correspondence to select important items for circulation. This was accepted.

Other Matters

Mr A.Jones would no longer represent the Council on the Oxford City Conservation Area Forum. The Council had no nomination to the Area Advisory Committee which he attended on behalf of the Oxford Preservation Trust and would no doubt represent the Council's views. The Chairman agreed to represent the Council in future.

Accounts

The final word in the VAT saga is that the Council will have to pay a rent for the use of the Mortimer Hall if it is to continue to reclaim VAT on expenditure it funds on the Hall maintenance etc. Tha Hall Committee would consider this.

Due to changes in Council Membership and appointments it was decided that Mrs Nurse should replace Mr Jones as a signatory to Council cheques.

Mr Batey asked the Clerk to investigate interest rates on deposits

The Auditor reported that the Audit of the council's accounts for the year ended 31st March 1998 had been completed there being no matters to be drawn to the Council's attention.

Oxford City F.C. Lighting

The Clerk had received a telephone call from Mr M. Woodley, the Club's Chairman to confirm that the stand to be erected only covered the present standing area and would be of equal height to the existing stand.

The Clerk took the opportunity to raise with him the problem of glare from the floodlights, inconveniencing motorists. Mr Woodley denied any knowledge of the problem. Mr Taylor who has contacts with the Club said that he would investigate the matter. Mr Bartleet who had been involved would copy correspondence to the Clerk who would write to Mr Woodley.

Recreation Ground

The Engineer's report on the swings was received. One set was condemned and would have to be removed. Others needed lubrication and rust treatment. The question of replacement was deferred. The Clerk would bring catalogues to the next meeting.

In view of the reduction in vandalism in the Mill Lane area it was decided to investigate the provision of play equipment in the area. The Clerk would seek the consent of the Oxford Preservation Trust to the erection of equipment on it's land.

It was decided to ask the City Works for a quotation for a larger litter bin to be provided near the swings on the Mortimer Hall site.

Highways

Inconvenience was caused to Mill Lane residents by traffic leaving the Victoria Arms access, turning left and expecting to gain access to the A40. The Clerk was asked to investigate the possibility of a road sign at the access junction indicating the dead end.

Copies of the Definitive Footpath Map to be circulated.

The condition of the estate roads was discussed. The Clerk was asked to write to the City Council with copies to the County Council and the MP requesting that finds be made available for the repair work to be done.

The Club Committee now said that it had the expertise, within the Club, to undertake the work required with it's own resources, subject to assistance with costs of materials etc. The Chairman, Vice-chairman and Mr Batey and Mr Taylor would visit the Club on 22nd May 1999 and report to the next meeting.

The Club wished to erect a lock-up garage to which no objection was raised. It would be subject to Planning Consent and it being in good condition.

Mural

A satisfactory reply had been received from the City Council agreeing the provision of a protective coat and future maintenance. The artist had recommended that the subjects chosen should have a common theme such as the outdoors. This was accepted and it was decided to ask the artist to select topics and include the icing up of the Ferry (from the Old Marston booklet), a Village Fete and Maypole, an Oxfordshire Wagon & Horses and the development of Penicillin which had strong links with the Parish.

Burial Ground

The Clerk recommended that as the conditions relating to Burials on the extension, now expressed by the Environmental Agency, had changed slightly a trial hole should now be dug to the east of the existing Burial Ground. This was agreed.

Other Matters

It was suggested that Mr A.Jones retirement should be marked in a tangible form. This was deferred to the next meeting.
