The Clerk was asked to write to enquire whether money raised locally could be used to stem the proposed closure.

#### Allotments

Several letters and discussions had taken place since the last meeting and it was decided to refer the matters raised to a sub-committee comprising the Chairman, Vice-chairman, Mr Carrington and Mr Phipps to which Dr Swift would be invited. The Clerk to arrange the meeting. The wayleave agreement with Mr R Ward was approved.

#### Marston Saints Football Club

The formal agreement to be entered into with the Club was approved. The Clerk would arrange for it to be signed.

Mr Phipps reported on the meeting with the Club's representatives. The major problem was the condition of the toilets and showers and the lack of a separate female toilet. The Club said it would have some outline plans drawn for consideration in due course.

A schedule of the Club's events had been considered and the recommendations submitted by Mr Phipps in the form of the light type on the Club's submitted list was accepted by the Council. The list is attached.

#### Highways

The Clerk and Councillor Bartleet had received submissions on behalf of Ashlong Road residents by Mr J.Sparrowhawk. These listed various deficiencies in Highway maintenance and dangers to the public. They had also been sent to the City Councillors for the area and the Clerk was asked to give the Parish Council's support to the campaign.

Mrs Tiwari had asked that the condition of Lewell Avenue should be drawn to the Highway Authority.

Problems with geese and obstructions to the footpath from Elsfeld Road to the Allotments continued. The Clerk was asked to write to the City Engineer to request that action be taken.
