PAV17/08/02 Apologies for Absence: None

PAV17/08/03 Public Participation: NONE.

PAV17/08/04 It was RESOLVED to accept the minutes of the previous meeting held on the 25th July 2017.

PAV17/08/05 Matters arising omitting those for which an agenda heading follows:

- Fire Alarm system is installed but neds wiring to mains. Clerk is in contact with an electrician to wire alarm and look at disabled toilet light
- ➤ The Clerk felt the leak in the roof was an urgent matter and so got Dave Hook to do some repairs. IH suggested sending copy of Dave Hooks invoice to Stanleys so at least they are aware.
- ➤ BL asked if heating/plumbing system working. TG replied emersion heater needs attention but otherwise yes all OK.
- > The Clerk confirmed that one bat and one bird box had been purchased but needed installing.

JB would like to personally pay for miniature conifers or shrubs in front of the building and either side of the footpath. Clerk to get costings.

MC said about a sign above the main door informing people it is "The Roy Garner Pavilion" and another sign somewhere saying something like "Old Marston Parish Council Pavilion – Home of Marston Saints Football Club." Clerk to get costings.

PAV17/08/09 Anything of an urgent nature which has come to the Clerk's attention since setting the agenda:

The Clerk advised the meeting that Sam White, vice-chairman of Marston Saints, had emailed saying that the men's team had a friendly on Saturday (26th) and had asked that they have access to the changing rooms in the new clubhouse for the fixture. JB suggested that this could be a good idea but too early to make any decision just yet. It was RESOLVED to have the flooring stored safely in the new building somewhere for the time being.
